ORDER


Dated, 19.05.2009

Complainant Sri Biswendu Bhattacharjee appeared. His written rejoinder dated 18.05.2009 received by this Commission on the same date is put up today and attached to records.

2. OP Sri G. Chakraborty, Superintendent of Police, Traffic, Agartala and the SPIO appeared and submitted his written representation, copy of which is furnished to the complainant.

3. Heard oral submissions placed by both the parties. Perused the written complaint with written rejoinder thereto of the complainant and the written representation of the OP.

4. It reveals from the record that although the complainant in his written complaint dated 29.04.2009 alleged to have not been furnished with three information in full, but in his written rejoinder dated 18.05.2009 submitted that in the meantime, the OP being the SPIO furnished some more information to him on 14.05.2009, which covered all his requirements except the information as to how much money has been collected as fine from different vehicles between 1st January, 2008 and 15th March, 2009. However, in his oral submission, the complainant further reduced his claim for information only in respect of the revenue collected during the month of March, 2009. The OP submitting a petition in writing undertook to furnish the above information within 7 days. The complainant expressed his satisfaction with the written assurance given by the OP.





5. Having regard to the facts and the circumstances narrated above, we conclude the findings that the complainant is entitled to have access to the information, namely, how much money has been collected as fine from different types of vehicles in the month of March, 2009.

6. Hence, the complaint stands disposed of with the order that the OP Sri G. Chakraborty, Superintendent of Police, Traffic, Agartala and the SPIO shall provide the information mentioned in the preceding paragraph to the complainant within a period of 7 days from the date of passing of this order.

7. Let copy of this order be sent to the complainant and the OP. Also send a copy of this order to the Director General of Police, Government of Tripura being the head of the Public Authority.
