**ORDER**  
**Dated 17.05.2010**

The written complaint dated 12.05.2010 of Sri Tapan Biswas (here in after referred to as the complainant) sent by courier post has been received by this Commission on 17.05.2010. Brief facts leading to this complaint are that a portion of land of the complainant was acquired by the L.A. Collector, South Tripura District vide L.A. Case No-01/B/09 Sl. No. 13 Ref No- F 4(32)DM/S/LA/B/08/311-68 and accordingly, a notice was served to the complainant directing him to collect Rs. 3,53,857/- from the office of the Sub-Divisional Magistrate (SDM), Belonia on 11.02.2010. But, the SDM, Belonia actually paid an amount of Rs. 3,28,471/- to the complainant vide cheque No-014784 dated 16.04.2010. Under this background, the complainant vide his written request dated 03.03.2010 submitted to the State Public Information Officer (SPIO) in the office of the SDM, Belonia under section 6(1) of the RTI Act, 2005 (for short the Act) accompanied by the requisite amount of application fee wanted to know the reasons for deduction of Rs. 25,386/- from the awarded compensation amount. Having no response from the concerned SPIO within the statutory period prescribed by the Act, the complainant has now approached this Commission with this complaint seeking direction to have access to the information sought for by him vide his written request dated 03.03.2010.



2. This Commission found adequate materials to take cognizance of the complaint and accordingly, it was registered under section 18(1) of the Act.

3. Considering the simple nature of the information sought for and in order to save time and expenditure of both the complainant and the SPIO, particularly of the complainant for their personal appearance before this Commission at Agartala on the date of hearing, this Commission decides the complaint on its merit in the absence of the complainant and the SPIO with the orders that the Opposite Party (OP) Sri Sanjay Chakrabarti, SDM, Belonia being the SPIO shall furnish to the complainant in writing the reasons for deduction of Rs. 25,386/- from the total amount of compensation awarded in favour of the complainant along with the certified copies of supporting documents, if any, within a period of 15 days from the date of passing of this order and shall furnish a report of compliance to this Commission forthwith. A copy of the written complaint dated 12.05.2010 of the complainant may be sent to the SDM, Belonia for ready reference.

4. With the above orders, the complaint stands disposed of.

5. Let copy of this order be sent to the complainant and the OP.
